Mercedes Benz of Nottingham Junior Series Tennis Tournament 2004

Conditions

General

1. The tournament is sanctioned by the Lawn Tennis Association and will run in strict accordance with the Rules of Tennis, the Rules of The Association and the Regulations for the Management of Lawn Tennis Tournaments, including the LTA Code of Conduct.
2. Every competitor in the singles events of the LTA Official Tournament must be a member of the LTA Membership Scheme and have a National Rating or be a member of the host club with a Club Rating, provided has registered for the Club Rating Scheme. This shall not apply to 10 & Under events. The Committee reserves the right to run a Qualifying or a "B" event if entries are over subscribed.
3. Any player may be required to submit to a doping control test, which may be carried out at any time with no notice given.
Failure to submit to the test will be treated as if a positive result has been obtained.
4. Players may NOT enter two tournaments that run over the same period and must be available for the entire duration of the event.

Entries

In the interests of keeping the Tournament to reasonable size, entries may be limited in certain Rating categories.

The Committee reserves the right to refuse any entries without assigning a reason. Any entry containing a note as to restricted availability will not be accepted.

6. Players may enter 2 singles and 1 doubles event. Weather permitting singles events will include a structured Playback that is an integral part of the tournament and is not optional.
7. No player may withdraw from the event, **including the structured Playback event**, after the draw for the main event has been made, except for injury, illness or personal emergency.

The Draw

8. A player's rating is that at the closing date. Seeding will be based upon the player's rating at the time of the Draw.
9. Players will be informed of the time and date of their **first match**.
10. In the main Draw, matches will be the best of 3 sets, tie-break at 6 all in all sets. Under 10 events will play sets to 4 games and a 3rd set tie-break.

The Tournament

The decision of the referee in all matters in connection with the Tournament is final. No complaint relating to the

Tournament can be entertained by the committee unless lodged in writing with the Secretary/Chairman within 48 hours of the cause of complaint.
